#### **GUIDELINES FOR MEMBERSHIP APPLICATION**

1. Capital letters should be used for filling up.
2. Married persons can apply for Annual / Life membership.
3. One can apply for Associate membership only in case the marital status is Single.
4. One-time Registration fee is Rs.1000/- for Life / Annual Member and Rs.500/- for Associate Member.
5. Annual Membership Subscription for Annual member is Rs. 1,500/- and Associate Member is Rs.1000/-.
6. One-time Registration fee and Annual Subscription will attract an extra 18% GST.
7. For Life Membership one-time membership fee is Rs. 15,000/- plus extra 18% GST.
8. The Executive committee holds the right to accept or reject the request for membership.
9. Minimum donation, which can be construed as yearly activity fees, to be contributed by Life / Annual and Associate members will be decided by the committee to help club meet rising expenses towards Puja, round the year cultural events and Trust activities. At present the minimum donation is Rs. 4,000/- for Life / Annual Member and Rs. 2,000/- for Associate Member.

**Considering the year-round charitable activities being carried out by the SMCA Trust, Members are requested to donate generously over and above the minimum donation amount.**

10. GST is not applicable for donation amount.
11. Associate members will not have voting rights in Annual General Body Meeting and will not be eligible for any posts of Executive Committee.
12. The membership once accepted will be valid until & unless the membership subscription is defaulted for current year or membership has been cancelled by the Executive committee.
13. The communications to all by default, will be through emails only.
14. The members should not act in anyway detrimental to the club's vision and the rules and regulations laid down.
